





- (e) To apply the whole or any part of the Trust Property of fund, whether capital or income, towards payment of expenses of the Trust or towards all or any of the purposes of the Trust.
- (f) To enter into contracts on behalf of the Trust and to rescind them.
- (g) To appoint, terminate, suspend or otherwise deal with the staff and employees of the Trust and any of its universities deemed universities or institutions.

(h) To incur all necessary expenses, in connection with the Trust and its management and activities.

(i) To do all acts, deeds and thanks as may be necessary for carrying out all or any of the objects quactivities of the Trust.

# 7. BOARD OF TRUSTEES & THEIR POWERS

The Managing Trustee along with the other Trustees shall constitute the Board of Trustees. The Board shall have the following powers

- To open accounts in any scheduled Banks and operate the same in the name of the Trust and such Bank accounts may be operated by the Managing Trustee and or by such Trustees nominated by the Managing Trustee.
- ii) To acquire or purchase, to take on lease or sell, transfer or gift or exchange or lease or hire or otherwise alienate any money, land, building and movable and immovable properties of every description belonging to the Trust. To take over or merge with other trusts or institutions having similar objects.
- iii) To construct new building(s) or structure(s) or rebuild improve, enlarge or add to all or any one or more of the buildings of structures forming part of the Trust properties from the Trust fund.
- To invest all the funds of the Trust not immediately needed for the purpose of the Trust, in such manner as deemed fit and proper.
- v) To authorise any person to receive, collect and enforce recovery of all monies due or payable to the Trust and grant necessary receipts and discharge thereof.
- To appoint any person to receive notices and to appear before Courts,
   Tribunals, public office etc.
- vii) To appoint any person to prosecute and defend all suits and other legal proceedings.
- viii) To give loans to any Company or Firm of good standing and reputation for carrying out the objects mentioned in clause 3 (i) to (xvii) or to invest the funds as per the provision of section 11 (5) of the Income Tax Act 1961 or such other amended provision relating to Investment of funds of the Trust.
- ix) : To consider such of the matters, as may be referred to from time to time, by the Managing Trustee.

To apply for and obtain grants or loans from Government or other Authorities or Banks on such terms and conditions, as they may think fit, in regard to securities and interest and shall for this purpose, be entitled to execute, or authorise anybody to execute such mortgage or charges on the properties of the Trust, as may be necessary.

No act or proceedings of the Board of Trustees or of the Managing Trustee shall be deemed to be invalid by reason only of the defect in the appointment or constitution of the Board of Trustees or any member thereof, on the ground that any member of the Board of Trustees was not entitled to hold or continue in office by reason of any irregularities in his appointment or by reason of such act-having been done or proceeding taken during the period of vacancy in the office of the Managing Trustee or any other Trustee.

## 11. MEETINGS

The Trustees shall meet as often as may be necessary for the efficient conduct of the Trust, but not less than once a year. The Trustees may take decisions on any question either on meetings or by circulation of papers. In respect of any investment of the Trust Fund and any other matters touching the powers of the Managing Trustee, the decision of the Managing Trustee shall be final. And they shall hold office for their respective lives or for as long as they are willing to act as Trustees.

## (B) Board of Trustees:

The Trustees shall collectively be called Board of Trustees.

## (C) Maximum number of Trustees:

The Trust shall have as many Trustees as the Board may decide from time to time. Whenever the strength of the Board is increased from the initial strength of Five, it shall be increased by multiples of Four.

# (D) Appointment of Trustees:

Each of the First Trustees could nominate any of their children in their place at any time. Whenever the strength of the Board is increased each of the First Trustee could nominate one fourth of the increased strength. At any time the First Trustees or the Trustees nominated in their place shall be represented equally at the Board. The board will appoint new trustees as per this clause.

#### (E) Managing Trustee:

Trustee of the First Part Mrs. LEENA shall be the First Managing Trustee.

#### (F) Secretary :

Trustee of the Third part Mrs. M.SINDHUJA shall be the First Secretary of the Trust.

(a) To appoint sub-committee or any sub-committees for the management of the institutions(s) or centres of the trust, and such sub-committee shall act in accordance with the powers given by the Founder Trustee in writing. The constitution of such sub-committees may be changed by the Founder Trustee at any time or even dissolved.

- (b) To make, alter, rescind any rules and regulations for the effective management and administration of the Trust or of any institutions(s) of the Trust.
- (c) To receive for the objects of the Trust donations, contributions, endowments, grants and legacles from individuals, charities, other trust funds and institutions, the University Grants Commission and Governments, State or Central and the bodies or authorities through whom they disburse their funds, on such terms and conditions as may be accepted by the Founder Trustee.
- (d) To donate funds to other trusts having similar objects.
- (e) To apply the whole or any part of the Trust Property of fund, whether capital or income, towards payment of expenses of the Trust or towards all or any of the purposes of the Trust.
- (f) To enter into contracts on behalf of the Trust and to rescind them.
- (g) To appoint, terminate, suspend or otherwise deal with the staff and employees of the Trust and any of its Schools, universities deemed universities or institutions.
- (h) To incur all necessary expenses, in connection with the Trust and its management and activities.
- To do all acts, deeds and things as may be necessary for carrying out all or any
  of the objects or activities of the Trust.
- (i) To delegate any powers in respect of administration of the Trust and Institutions belonging to or run by the Trust, to such person or body to such extent and in such manner as Founder Trustee thinks fit.

- (k) To organize and establish printing press and print and publish books of knowledge, pamphlets, etc., for the spread of education.
- (f) The Powers of the Founder Trustee contained herein shall be exercised by the Board, after him.

# 7. BOARD OF TRUSTEES & THEIR POWERS :

The Founder Trustee and other Trustees shall constitute the Board of Trustees. The Board shall have the following powers

- i) To open accounts in any scheduled Banks and operate the same in the name of the Trust and such Bank accounts may be operated by the Founder Trustee/Managing Trustee and or by such Trustees nominated by it.
- ii) To acquire or purchase, to take on lease or sell, transfer or gift or exchange or lease or hire or otherwise alienate any money, land, building and movable and immovable properties of every description belonging to the Trust. To take over or merge with other trusts or institutions having similar objects.
- To construct new building(s) or structure(s) or rebuild improve, enlarge or add to all or any one or more of the buildings of structures forming part of the Trust properties from the Trust fund.
- iv) To invest all the funds of the Trust not immediately needed for the purpose of the Trust, in such manner as deemed fit and proper.
- v) To authorise any person to receive, collect and enforce recovery of all monies due or payable to the Trust and grant necessary receipts and discharge thereof.
- vi) To appoint any person to receive notices and to appear before Courts, Tribunals, public office etc.
- vii) To appoint any person to prosecute and defend all suits and other legal proceedings.

viii)To give loans to any Company or Firm of good standing and reputation for carrying out the objects mentioned in clause 3 (i) to (xvii) or to invest the funds as per the provision of section 11 (5) of the Income Tax Act 1961 or such other amended provision relating to Investment of funds of the Trust.

- ix) To consider such of the matters, as may be referred to from time to time, by the Managing Trustee.
- X) To add Institution(s) or Center(s) and for to close; modify or replace any existing institution or center belonging to the Trust.
- xi) To apply for and obtain grants or loans from Government or other Authorities or Banks on such terms and conditions, as they may think fit, in regard to securities and interest and shall for this purpose, be entitled to execute, or authorise anybody to execute such mortgage or charges on the properties of the Trust, as may be necessary.

Notwithstanding anything stated in this Trust Deed, the board of Trustees shall have the power to sell, transfer, and exchange or otherwise allenate any land, building or other immovable property belonging to the Trust only on the basis of a majority decision.

- 8. The Trustaes may reimburse themselves or pay or disburse out of the Trust money in her or their hands all expenses properly incurred by her or them, in the execution of the Trust and in discharge of duties imposed on him or them under this Trust.
- The income and funds of the Trust will be solely utilised towards its objects and no portion of it will be used or applied for the benefit of persons covered by Section 13(3) of the Income Tax Act 1961.
- 10. No act or proceedings of the Board of Trustees or of the Founder Trustee/ Managing Trustee shall be deemed to be invalid by reason only of the defect in the appointment or constitution of the Board of Trustees or any member thereof, on the ground that any member of the Board of Trustees was not entitled to hold or continue in office by reason of any irregularities in his appointment or by reason of

such act having been done or proceeding taken during the period of vacancy in the office of any of the Trustee.

#### 11. MEETINGS:

The Trustees shall meet as often as may be necessary for the efficient conduct of the Trust, but not less than once in Six months. The Trustees may take decisions on any question either on meetings or by circulation of papers. In respect of any investment of the Trust Fund and any other matters touching the powers of the Managing Trustee the decision of the Founder Trustee / Board shall be final. The decision of the Trustees shall be by majority. All the meetings of the Trustees shall be presided over by the Founder Trustee. The Founder Trustee shall have the power to nominate a Trustee who shall preside over the meetings in his absence. Subject thereto and/or failing such nomination, the Trustees present at a meeting shall vote to elect one amongst them to preside over the meeting.

## 12. MINUTES, ACCOUNTS & AUDITS:

The Trustees shall maintain true and correct accounts of the Trust and a correct record of their deliberations and get the accounts, duly audited by the Chartered Accountant. The accounts shall be closed on every 31st March.

# 13. SPECIAL POWERS OF THE FOUNDER OF THE TRUST:

- i) The Founder Trustee and after him the Board of Trustees shall have the powers to add, delete or after the objects of the Trust, provided such addition, deletion or afteration will be carried out, only with the approval of the Commissioner of Income Tax and a such amendment shall not extend to aftering the basic character or objects of the Trust.
- ii) The Founder Trustee only shall have the power to Change any of the Trustees.

On dissolution of the Trust, the net assets of the Trust shall be transferred to a Trust having similar objects of this Trust. The proceeds shall under no circumstance be distributed among the Trustees.
